### Higher Education Emergency Relief Fund Report ~ Emergency Financial Aid Grants to Students

#### 7/10/2021 Quarterly Report

**MyComputerCareer.com/Techskills (OPE ID: 041245)** received education stabilization funds under Section 18004(a)(1) of the Coronavirus Aid, Relief, and Economic Security Act (“CARES Act”), HEERF II grants under the 2021 Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA, Section 314 of the Consolidated Appropriations Act, 2021), and HEERF III grants under the American Rescue Plan Act of 2021 (ARP). This Fund Report applies to the student portion received under the HEERF II & III that is designated exclusively for emergency financial aid grants to students.

The institution appreciates that Congress and the President have made these critical funds available for eligible students who have expenses related to the disruption of campus operations due to the coronavirus pandemic.
