

Higher Education Emergency Relief Fund Report ~ Emergency Financial Aid Grants to Students

MyComputerCareer at Raleigh (OPE ID: 04206500) received education stabilization funds under Section 18004(a)(1) of the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act"), HEERF II grants under the 2021 Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA, Section 314 of the Consolidated Appropriations Act, 2021), and HEERF III grants under the American Rescue Plan Act of 2021 (ARP). This Fund Report applies to the student portion received under the HEERF II & III that is designated exclusively for emergency financial aid grants to students.

The institution appreciates that Congress and the President have made these critical funds available for eligible students who have expenses related to the disruption of campus operations due to the coronavirus pandemic. We take receipt of these federal funds seriously and are distributing them in accordance with the CARES Act and implementing guidance.

The institution is making the below information available for transparency purposes and in compliance with the U.S. Department of Education's ("Department") Electronic Announcement of May 6, 2020. - 1. The institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used the applicable amount of funds designated under the CRRSAA and ARP (a)(1) and (a)(4) programs to provide Emergency Financial Aid Grants to Students.
- 2. The total amount of funds that the institution has received from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) and (a)(4) programs: \$2,751,380 (HEERF II \$1,756,371, HEERF III \$995,009)
- 3. The total amount of Emergency Financial Aid Grants distributed to students under the CRRSAA and ARP (a)(1) and (a)(4) programs as of the date of submission is \$2,302,606.47.


The amount to be distributed to each qualifying student will be based on the following established need criteria that prioritizes students most in need. This is based on all students who were active students effective April 1, 2021 and is reflective of their EFC on a cleared ISIR.

| EFC Range                 | CRRSAA Award | ARP Award | <b>Total Award</b> |
|---------------------------|--------------|-----------|--------------------|
| 0 – 5711                  | \$1,630.83   | \$923.74  | \$2554.57          |
| 5712 or higher, or no EFC | \$1,087.14   | \$616.17  | \$1703.31          |

The appropriate amount will be distributed as quickly as possible. Below outlines the steps to the students regarding the Emergency Financial Aid Grants.

- Students who were Active as of 4/1/2021 will receive an email announcement describing the purpose of
  the grant, the qualifications of the grant and method of distribution. In the email will be a link to
  complete a questionnaire to confirm any address changes or if the student wishes to have a portion or
  all of the grant applied to any applicable outstanding balance due to the school. The student will have
  until 12/10/2021 to respond to the request.
- 2. Unless a request for application of the debt to be applied to cover school debts, the funds will be distributed no later than 1/10/2022 to all eligible recipients.
- 3. Checks not cashed by 2/28/2022 will be cancelled and those funds will be redistributed to by the end of the HEERF grant performance period.
